Tours for the Spouse –

We most certainly will be visiting the **Glensheen Mansion** and would like you to join us. Located on the Lake Superior shoreline, the Glensheen was built as a Jacobean Style Mansion with 39 rooms on about 7 acres. Congdon creek runs through the estate before entering the lake. Taking over three years to build and finally completed in 1908, the structure contains Late Victorian and Art Nouveau styling. There is also a carriage house and grounds keepers quarters on the grounds.
