**VALIDATION FOR RETURN:** Tickets will be good for return trip only when validated by Joint Agent at destination or at an intermediate point en-route returning at which a Joint Agency is located provided tickets read on return trip through such point. Except that tickets to San Francisco, sold June 27 to July 5, account N. E. A. Convention, will be validated at San Francisco and only when tickets bear the stamp of the secretary of the National Education Association certifying to holder's membership therein—which membership can be obtained from the secretary at San Francisco at the cost of \$2.00. A fee of fifty (50) cents for the validation of each ticket will be collected by Joint Agent.

**STOP-OVERS:** Stop-overs allowed within final limit of tickets as follows:  
**ON GOING TRIP:** On tickets sold April 18, 19, 20, May 12, 13, 14, 29, 30, 31 and on Convention tickets sold June 5, 6 and 10 to 22, and June 27 to July 5 inclusive. At and west of \*Missouri River Gateways, St. Paul, Duluth, Memphis and New Orleans, except that on tickets to San Francisco sold account N. E. A., stop-overs will be allowed on going trip, only within going transit limit of July 14, 1911.

**ON GOING TRIP:** On Summer Tourist tickets sold June 1, to September 30, stop-overs will be allowed at all points en route within the final limit of ticket.

**ON RETURN TRIP:** At and west of Chicago, Peoria, Bloomington, St. Louis, Memphis, New Orleans, St. Paul and Duluth, but passengers must reach original starting point within final limit of ticket.

\*Missouri River means Council Bluffs, Iowa, Omaha, Neb., St. Joseph and Kansas City, Mo., and Atchison and Leavenworth, Kan.

**TRANSIT LIMITS:**  
**GOING TRIP** must commence on date of sale;  
**RETURN TRIP** must commence on date and train stamped on validation certificate. When presented in person by the original purchaser to the validating agent, tickets will be validated not to exceed one (1) day in advance of departure.

**RETURN LIMITS:**  
 On convention tickets sold June 5, 6, 10 to 22, and June 27 to July 5, limit is Sept. 15. On tickets sold April 18, 19, 20, limit is June 30. On tickets sold May 12, 13, 14, 29, 30 and 31, limit is July 31.

On Summer Tourist tickets sold June 1 to September 30, limit is October 31, 1911.

# ROUND TRIP SUMMER TOURIST TICKETS TO YELLOWSTONE NATIONAL PARK

SEASON JUNE 15 TO  
SEPTEMBER 15, 1911

**Stop-Overs at Livingston During Yellowstone Park Season.**—During the Yellowstone Park season (June 15 to September 15), stopovers will be allowed at Livingston, Mont., in addition to those usually granted on stopover tickets, on all classes of tickets both east bound and west bound, reading to points on or via the Northern Pacific Railway, regardless of limit, except that on one way tickets stopover must not exceed thirty (30) days. The stopovers will be obtained on continuous passage tickets by deposit of ticket on arrival at Livingston, with agent at that point, who will arrange for extension of limit by exchange for a new ticket bearing same conditions.

Passengers holding through sleeping car tickets will also be furnished sleeping car stopover checks at Livingston on application to Pullman conductor. Sleeping car tickets should, however, be purchased to and from Gardiner when passengers know before starting of their intention to go into the Park.

**\$5.50 Ticket**—Includes rail and stage transportation Livingston to Mammoth Hot Springs and return. Dates of sale June 14 to September 19, 1911.

**\$8.00 Ticket**—Includes rail and stage transportation Livingston to Mammoth Hot Springs and return and two meals (lunch and dinner) at Mammoth Hot Springs Hotel. Dates of sale June 14 to September 19, 1911.\*

**\$28.00 Ticket**—Includes rail transportation Livingston to Gardiner and return, and stage transportation Gardiner to Mammoth Hot Springs, Norris, Lower and Upper Geyser Basins, Yellowstone Lake, Grand Canyon and Falls of the Yellowstone and return to Gardiner. This ticket does not cover hotel accommodations. Dates of sale June 14 to September 14, 1911.\*

**\$55.50 Ticket**—Includes rail transportation Livingston to Gardiner and return, stage transportation Gardiner to Mammoth Hot Springs, Norris, Lower and Upper Geyser Basins, Yellowstone Lake, Grand Canyon and Falls of the Yellowstone and return to Gardiner, and not to exceed 5½ days accommodations at the Yellowstone Park Hotel Co.'s hotels. Dates of sale June 14 to September 14, 1911.\*

**\$33.00 Ticket**—Includes rail transportation Livingston to Gardiner and return, stage transportation Gardiner to Mammoth Hot Springs, Mammoth Hot Springs to Norris and Norris to Grand Canyon and return to Gardiner and 2½ days' accommodations at the Yellowstone Park Hotel Co.'s hotels. Dates of sale June 14 to September 17, 1911.\*

**\$62.00 Ticket**—Includes rail transportation from St. Paul, Minneapolis, Duluth or Superior to Gardiner and return to any one of the above named points, or via Billings and the "Burlington" to ††Missouri River terminals via direct line or Denver, or via Denver and any other direct line, stage

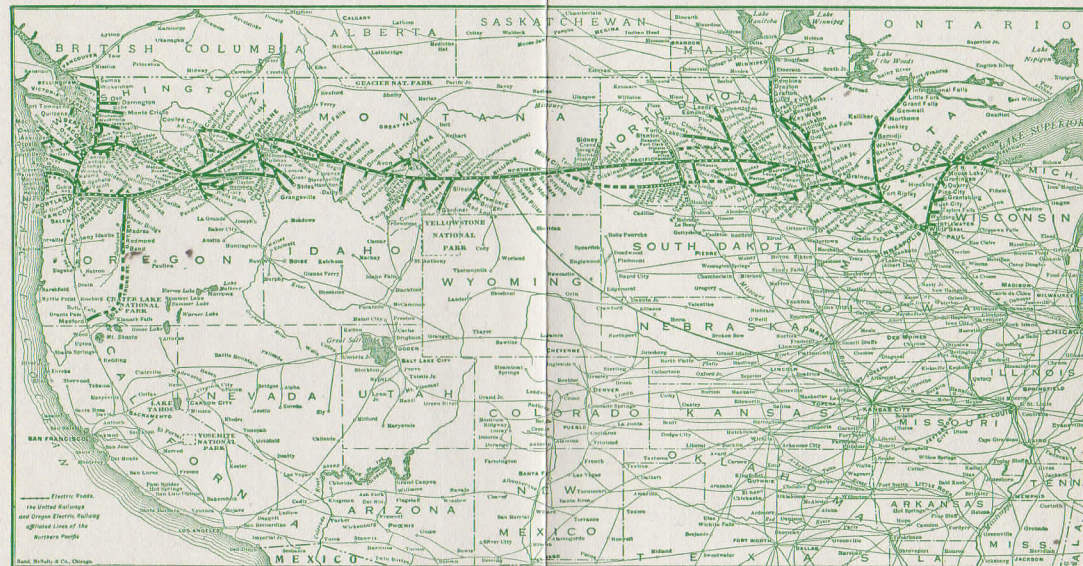

**\$32.00 Ticket**—Includes rail transportation from St. Paul, Minneapolis, Duluth or Superior to Gardiner and return to any one of the above named points, or via Billings and the "Burlington" to ††Missouri River terminals via direct line or Denver, or via Denver and any other direct line. Dates of sale June 12 to September 16, 1911. Final limit \*October 31, 1911.

**\$57.00 Ticket**—Includes rail transportation from St. Paul, Minneapolis, Duluth, or Superior to Gardiner and return to any one of the above named points, or via Billings and the "Burlington" to ††Missouri River terminals via direct line or Denver, or via Denver and any other direct line and stage transportation Gardiner to Mammoth Hot Springs, Norris, Lower and Upper Geyser Basins, Yellowstone Lake, Grand Canyon and Falls of the Yellowstone and return to Gardiner. This ticket does not cover hotel accommodations. Dates of sale June 12 to September 12, 1911. Final limit \*October 31, 1911.

**\$84.50 Ticket**—Includes rail transportation from St. Paul, Minneapolis, Duluth or Superior to Gardiner and return to any one of the above named points, or via Billings and the "Burlington" to ††Missouri River terminals via direct line or Denver, or via Denver and any other direct line, stage transportation Gardiner to Mammoth Hot Springs, Norris, Lower and Upper Geyser Basins, Yellowstone Lake, Grand Canyon and Falls of the Yellowstone and return to Gardiner, and hotel accommodations for not to exceed five and one-half days at Yellowstone Park Hotel Co.'s hotels. Dates of sale June 12 to September 12, 1911. Final limit \*October 31, 1911.

**\$107.25 Ticket**—Includes rail transportation from St. Paul, Minneapolis, Duluth or Superior to Gardiner, stage transportation Gardiner to Mammoth Hot Springs, Norris, Lower and Upper Geyser Basins, Yellowstone Lake, Grand Canyon, Falls of the Yellowstone, and to Yellowstone, Mont., hotel accommodations at the Yellowstone Park Hotel Co.'s hotels for not to exceed sixteen meals and five nights' lodgings between Gardiner and Yellowstone, Mont., and rail transportation from Yellowstone, Mont., either via Oregon Short Line R. R. and Union Pacific to ††Missouri River terminals, or via O. S. L. R. R. Oden, and any line Oden to Denver, thence via the "Burlington," Union Pacific R. R., A. T. & S. F. Ry., C. R. I. & P. Ry., or Mo. Pac. Ry. to ††Missouri River terminals or via Colorado Springs or Pueblo and direct lines to ††Missouri River terminals. Date of sale June 12 to September 12, 1911. Final limit †October 31, 1911.



**\$81.00 Ticket**—This ticket covers rail and stage transportation ONLY (no meals or lodging being included therein) for the same tour as the \$107.25 ticket. Dates of sale June 12 to September 12, 1911. Final limit †October 31, 1911.

**\$51.00 Ticket**—Includes rail transportation from St. Paul, Minneapolis, Duluth or Superior to Gardiner, returning from Yellowstone, Mont., either via Oregon Short Line R. R. and Union Pacific to ††Missouri River terminals or via O. S. L. R. R. Oden, any line Oden to Denver; thence via the "Burlington," Union Pacific R. R., A. T. & S. F. Ry., C. R. I. & P. Ry., or Missouri Pacific Ry., to ††Missouri River terminals, or via Colorado Springs or Pueblo and direct lines to ††Missouri River terminals (does not include stage transportation or hotel accommodations in the Park). Dates of sale June 12 to September 12. Final limit †October 31, 1911.

**Fares for Children**—Tickets including rail transportation only, will be sold for children of five and under twelve years of age at one-half the fares quoted.

Tickets including stage and hotel accommodations in the Park, will not be sold for children, but children under eight (8) years of age will be granted half rates locally on stage lines and at Park hotels.

†Trip within the Park must be completed by September 20, 1911.

Tickets to Gardiner and return, and to Mammoth Hot Springs and return, and to Grand Canyon and return, must be validated for return passage at Mammoth Hot Springs Hotel. Tickets to Mammoth Hot Springs, including stage transportation or stage and hotel accommodations in the Park, must be validated at Mammoth Hot Springs Hotel. Side trip tickets from Livingston do not require validation.
