 The expenditure is recommended for the following reasons: (if space is not sufficient continue on back.)

At Vancouver Junction Yakolt Branch connects with main line four miles from Vancouver. Ranchers in vicinity of Junction advise that they will have fifteen or twenty carloads of farm produce, mostly prunes, to be shipped annually from this location if spur track is installed; also more or less shipments of hay, feed, etc., to be received inbound. The Commissioners of Clark County are improving county roads by macadamizing with crushed rock shipped from crusher near Yakolt and desire to unload crushed rock in this vicinity. By constructing spur track leading from Yakolt Branch, it will be in exclusive N.P. territory and all business moved via N.P. instead of being divided with other lines as would be the case if same was forwarded from Vancouver.

Construction of spur track is recommended as per sketch and estimate herewith submitted.

Situation inspected by Superintendent and Division Engineer and found that spur is not an operating necessity but apparently would be desirable from traffic standpoint.



