PNRA proposal to follow:

The NPRHA's two Archive sites are at the core of our mission to Preserve the History of the Northern Pacific Railway.

The West-End Archive is located at the PNRA facility in Burien which was formed by two NPRHA members and a GNRHS member in 2009 to preserve the many collections that were known to exist in the Pacific Northwest region. PNRA has five Railroad Heritage Organization members which include the NPRHA, GNRHS, Cascade Rail Foundation preserving the Milwaukee Road in Washington State, SP&SRHS and the Boeing Employees Model Railroad Club.

Over our first four and one-half years of operation, PNRA has grown and matured into a fully functional archive focusing on the railroads of the region. In doing this, we have:

- a. Completed the facility modifications to make it a safe and operational Archive.
- b. Installed permanent shelving systems of optimize the use of one-fourth of our storage space.
- c. Assembled computer and scanning stations to support crews of fifteen volunteers.
- d. Recruited and trained a volunteer base that meets regularly to work on the collections, which included 7,720 man-hours worked in 2014.
- e. Managed the NPRHA.org, GN-NPJointArchive.org and other web sites on the servers in Seattle.
- f. Built a strong contributor base of Friends that now provides over one-third of PNRA's revenue.
- g. Continued to receive many significant document and photo collections.
- h. Developed working relationships in the local Burien and King County heritage communities.

At this point, the NPRHA has the largest volume of all the collections at PNRA. The following are some of the largest individual NP-owned collections in Burien:

- a. Jim Fredrickson's collection purchased in 2012.
- b. Walt Ainsworth's massive NP collection of photos, document and maps received in 2013.
- c. Dave Sprau's NP collection of operating documents and maps.
- d. BN collection of NP drawings on over 46,000 microfiche cards.
- e. Ruth & Ed Eckes' NP collection of operating documents.
- f. Bill McKown's collection of NP equipment drawings and photos.
- g. George Werkema's NP slide collection.
- h. Dan Perkins' NP slide collection.
- i. Harold F. Stewart's NP photo collection.
- j. Barnie Overlie's film collection detailing many NP track improvement projects.

From PNRA's beginning, it has covered all expenses from three sources of revenue: monthly membership fees paid by our railroad history organizations; fulfillment services for the NPRHA and GNRHS online stores; and individual contributions from *Friends of PNRA*. Our largest expense remains the building mortgage interest. Thus, as we reduce the mortgage principal, our monthly expenses will be reduced. Ultimately, when the mortgage is paid off, the Archive will sustain itself as a permanent facility.

To reduce and pay off the building mortgage, PNRA began a Capital Campaign in 2013. As result of discussions initiated by the GNRHS with James J. Hill III, grandson of the founder of the Great Northern, the Campaign received its first success, a commitment to be the Campaign's lead contributor and provide a \$25,000 Challenge Grant. In the discussions, Mr. Hill also recommended the GNRHS and NPRHA to do the same, as a *force multiplier and momentum-builder*. Last week, the GNRHS Board voted to provide an additional \$50,000 for PNRA's Capital Campaign to secure the Archive by reducing the monthly mortgage interest payments.
