It is understood that in the delivery of tickets, or tickets and cash, at points on its own line, or in requesting another common carrier to make such delivery off the line of the Northern Pacific Railway Company, the latter company does so only as an accomodation without compensation and it is agreed that the railway company shall not be liable, beyond the return of the amount deposited, for damages for failure to deliver on its line, or for failure to make proper request upon another common carrier to make delivery. Damages for delay in making delivery on line or in making a request upon another common carrier for delivery off line are limited to a sum equal to the amount deposited. The liability of the delivering carrier, in case of off-line delivery of tickets, or tickets and cash, for failure to deliver or for delay shall be limited as above stated for the Northern Pacific Railway Company.
